FROM THE FINANCE COMMITTEE

New Banking Initiative.

We have transferred our bank account from the New Market Sonabank to the F&M Bank in Timberville. The new bank is closer to our bookkeeping services and provides us with a special checking account for non-profit organizations. We are looking into options for accepting members' payments other than by mailed checks. It would be helpful to get your feedback on what methods you would prefer to use. In addition, we now have our reserve funds in an interest-bearing savings account.

Delinquent Accounts

If you have attended past annual membership meetings, you must know that non-paying members have been an ongoing concern and discussion for many years.

Under the direction of our new board, we began sending out a series of letters to those with long-standing debts, giving them several opportunities to pay their bills, or to set up a payment plan. If our letters are ignored, we have signed on with a collection agency to collect the debts. We hope these member do not ignore the letters. We prefer to work with any of them to establish a means for paying off what they owe without taking more severe steps.

Nonpayment of dues and well repairs could lead to an increase in annual assessments for all other members, in order to maintain our budget priorities.

We encourage members not to let their delinquencies get so large that they are difficult to pay off. It is best to contact us to set us an agreement for monthly payments that fit your budget.

SHARED-WELL UPDATE

Well filters will now be changed automatically every two months on shared wells. This should provide clearer water and a better flow.

Since our wells are aging, we are looking at various options to keep them in good working order and to make sure they keep providing you with bacteria-free water.

In addition, all shared wells will be tested for e Coli and Coliform bacteria in March. The results will be sent out to all members and will posted on the website in the WELLS area.

ROADS UPDATE

As always happens this time of year, we have begun looking at the pothole situation that occurs due to water freezing on the roadbed.

Please be aware that potholes cannot be repaired until the road has thawed enough to work the gravel into the roadbed. That is usually toward the end of March to mid-April.

Our road crew has filled in with some temporary gravel to make for a smoother drive, but with freezing weather, it is often kicked back out into the road.

A spring evaluation will be done on all SMSA roads to determine what areas will need attention in 2022. Some of the initiatives will include the cutting of roadside brush, which is long overdue.

As a reminder, with the heavy spring rains that always come, this is a good time for members to clean out the fall leaves and debris from their driveways, ditches and culverts. We recommend Macanie Trucking at 540-325-2616 if professional help is needed on those areas.
